**Sign-Up Time:** Begins 1 Hour before Event for Best in Show Entrants. (Check Schedule for Official Times).

**Registration:** An Entry Form with signed liability waiver must be submitted to the Event Coordinator on the day of the Event before setting up on the grounds.

### About

The Car Show is a celebration of our automotive history, and highlights a hobby that enthusiasts want to share with the community. It's nostalgic for the older generations and a fulfilling pastime that hopefully sparks interest in vehicle-lovers of all ages.

There will be trophies awarded to the Best in Show for 1st, 2<sup>nd</sup>, and 3<sup>rd</sup> places.

Each vehicle entered will be offered one (1) free wristband for participation. Passengers will need to purchase wristbands before entering the grounds. Vehicles should enter the grounds via the parking lot.

Cars will be staged on the grassy area next to the Main Building.

### Rules and Regulations

If you are proud of your ride, bring it!

Participants in the Best in Show must provide the year, make, model, and any other information on their vehicle to the Event Organizer at Sign-In. The Event Coordinator will assign an Entry Number and create a sign with the above information.

Participants arriving late are free to display their vehicle in the exhibition but will not be eligible for a trophy.

Entry Numbers will be used for voting purposes.

Entry Numbers will be displayed in the front, right windshield, or on any other prominent area of display- easily seen by voters.

Fairgoers will be offered (1) ballot to vote for their favorite automobile. Best in Show will be determined by popular vote.

Ties will be determined by a coin toss. Example: If the tie is for first: winner of toss is 1st, loser is 2<sup>nd</sup>, etc.

## Baraga County Fair Release and Liability Waiver

I, (the "Participant"), acknowledge that I have read the Rules and Regulations of the Car Show and will abide by them. Any action that goes against those described in the Rules and Regulations is grounds for disqualification and/or removal from the Event.

I, the Participant, releases Baraga County Fair, its affiliates, its directors, officers, employees, and agents from all liabilities assumed by Participants involvement and participation in any and all activities related to the Baraga County Fair Car Show (the "Event"). I, the Participant, do hereby consent to participation in all actions and activities of the Event including but not limited to:

- 1. Assumption of Risk: I, the Participant, assume all risk of bodily injury, property damage, and personal damage that may occur by participating in the Baraga County Fair Car Show and, for myself/ourselves, their heirs, executors, and administrators, do hereby forever waive and release any and all claims against and agree to hold harmless the Baraga County Fair, its committee, sponsors, and volunteers, and successors or assigns of any kind from any and all claims which may be made for any cause whatsoever arising as a result of participation.
- 2. Photographic Release: I, the Participant, grant and convey to Baraga County Fair all right, title, and interest in any and all photographs, images, video or audio recordings of the Participant or his or her likeness or voice made by Baraga County Fair in connection with the Participant's involvement in the Event, including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- 3. Other: I, the Participant, expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Michigan and that this Release shall be governed by and interpreted in accordance with the laws of the State of Michigan. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

By signing below, I, Participant, express my understanding and intent to enter into this Release and Waiver of Liability knowingly and voluntarily.
